**PLUS Loan Pre-Approval:** For fast notification of pre-approval of the Parent PLUS loan, visit EAC's website at <https://www.eac-easci.org/knownow/>. The PLUS Pre-Approval Credit Request allows EASCI to determine the credit worthiness of a potential PLUS borrower before the parent goes through all of the steps to complete a PLUS Master Promissory Note.

**PLUS MPN:** The PLUS Master Promissory Note (MPN) will be used for all PLUS loans. You must complete an MPN on behalf of each student. By completing the PLUS MPN, you are authorizing BHSU to certify subsequent PLUS loans as requested. I understand that the Parent PLUS Loan will be processed for the amount shown on my son's/daughter's Award Letter and will not exceed the allowable maximums under the Higher Education Act.

## Your Rights and Responsibilities Regarding Your Federal PLUS Loan

## Choosing a Lender for Your Federal PLUS Loan

If you have never borrowed a Federal PLUS Loan, we suggest you choose a lender from the list below. These lenders use Education Assistance Corporation (EAC) to guarantee and disburse their loans to Black Hills State University electronically. **This results in optimal service to you**, from application through repayment. The lenders below are also committed to providing funds for Federal PLUS Loans to eligible BHSU students. No previous banking relationship is required, *except* for credit unions.

If you have previously borrowed a Federal PLUS Loan, we recommend that you continue to borrow through the same lender. If you decide to change lenders, you will need to fill out a new PLUS Master Promissory Note. Check your loan records for the lender name and information or contact our office for assistance.
