Bylaws and Staff Senate Redesign ad-hoc Committee – Update

- A couple of changes recommended for the grouping of employees: 1)
 Change "BHSU-RC" to "Center for Hospitality and Business" under Academic Affairs since all other BHSU-RC staff are included in the other groups. 2) Under Enrollment Management, "Disability Services & Testing" can be removed as that falls under the "Student Success Center".
- Discussed whether we should re-set the senate when we vote due to the complexity of tracking the open seats and the extent of the changes. There was also concern about maintaining the staggered terms.
- Discussed keeping Custodial Services with Facilities Services since they all report up to the same Assoc. VP.
- We need to have an all staff meeting to vote on the updated by-laws. We will post the recommended changes online and in January determine our next step for scheduling that whether before or after our vote for senators.
- Derrick will work on putting together a poll so we can determine the best day/time for an all-staff meeting.
