Thank you for your response to our inquiry regarding the Health Services Administration courses. I appreciate your explanation regarding the USD certification and the offer to partner with BHSU in offering this specialization to our students at Ellsworth Air Force Base via USD's online courses.

At this time, we would like to request permission to offer the following courses face to face in Ellsworth and possibly Spearfish.

HSAD 305 Health Service Systems

HSAD 350 Heath Service Administration Law and Policy

HSAD 410 Health Services Finance

HSAD 435 Admin. of Health Services Organizations

HSAD 450 Health Economics

HSAD 494 Health Services Internship

We have not yet had any discussions with Ellsworth Airforce Base administration regarding any course rotations for this program. My understanding is that the course rotations would be our decision. Giving our students the ability to take USD's online courses would add to the flexibility of their degree completion if they are not able to take BHSU's face to face courses.

Dear Dean Prosser,

Thank you for reaching out about the Health Services Administration courses. As you may know, our BBA-HSAD is recognized by the Association of University Programs in Health Administration (AUPHA). Recently, we received a recertification for four years. The AUPHA certification requires a significant commitment by faculty in terms of assessment, curriculum design, and internship supervision.

We have been considering online sections of the undergraduate courses and now have the staffing to be able to make that work. We have asked for approval to offer the following courses online in addition to the two currently taught online.

- HSAD 305 Health Service Systems
- HSAD 350 Health Services Admin. Law and Policy
- HSAD 410 Health Services Finance
- HSAD 435 Admin. of Health Services Organizations
- HSAD 450 Health Economics

We would plan to offer HSAD 305 online once per year (likely summer). The rotation for the other courses has not yet been determined. Each course would be taught at least every other year, if not every year. Have you had discussions with Ellsworth Airbase administration about the preferred rotations of the courses? We are open to discussions about when would be best to schedule them.

Thank you for the opportunity to work with BHSU on this MOU. The AACSB accreditation at BHSU for the core courses combined with our additional certification by AUPHA will allow for a high quality experience for the students.

How are you doing? I have a curriculum request to ask you about.

BHSU has recently signed a memorandum of understanding with Ellsworth Air Force Base. One of the parts of this MOU which was approved by the Board of Regents is to provide a health services administration program. Wording from that agreement is noted below:

Management/Health Care Administration: BHSU commits to create a program, Business Administration with a specialization in Health Services Administration, that is available in person and online. The university's School of Business previously offered a program as recently as 2008 in Health Services Administration, and the intent is to revive this initiative and improve on it. The former program would serve as a template with revisions to meet current needs. As current BHSU senior staff have experience with this past offering, the university believes it can have courses in this specialization ready as early as 2022.

We would like to request USD's permission to offer the following courses as part of our new Health Services Administration Specialization:

HSAD 305 Health Service Systems **HSAD 350** Health Services Admin. Law and Policy **HSAD 410** Health Services Finance **HSAD 435** Admin. of Health Services Organizations **HSAD 450 Health Economics HSAD 459** Health Services for Long-Term Care ** **HSAD 460** Long-Term Care Administration ** **HSAD 494** Health Services Internship

Would USD be willing to allow BHSU to offer these courses as part of the program noted above? Are there any other health service related classes that are offered routinely online? We would consider using those courses in our program as well. I would be happy to answer any questions that you may have. Dr. Carriveau, our Interim Provost, is also copied on this email and would entertain questions as well. Thank you for your time reviewing the request.
