Specific Education Undergraduate Requirements	20 CSR 2010-2.041 Eligibility Requirements for the CPA Examination (C) for candidates whose applications for the initial examination were postmarked on or after June 30, 1999, the concentration or major in accounting, or the equivalent of a concentration in accounting shall be sixty (60) semester hours or ninety (90) quarter hours or accounting and other related courses. At least thirty-three (33) semester hours or fifty (50) quarter hours shall be accounting courses with at least one (1) course in auditing and at least eighteen (18) semester hours or twenty-seven (27) quarter hours of accounting courses taken at the upper-division level, for the purpose of this rule "upper division level" courses shall mean courses taken beyond the elementary level. The remaining twenty-seven (27) semester hours or forty (40) quarter hours shall be in accounting or other areas of business administration such as business law, statistics, economics, finance, marketing, management, information technology and business communications. These courses shall be taken at an accredited college or university recognized by the board.
