

**Black Hills State University, HEERF Student Grant Programs  
Report for Q2 2021 (ending June 30, 2021)**

6. The method(s) used by the institution to determine which students receive Emergency Financial Aid Grants and how much they would receive under the CRRSAA and ARP (a)(1) and (a)(4) programs.

Round two of HEERF II funds were used to target two student groups. Funds were divided and 33% of funds identified for students enrolled in Summer semester and 67% for students enrolled in Fall semester. A student could receive disbursements for both if enrolled in both. Disbursements were made to the following undergraduate student groups:

- Pell eligible
- Not Pell eligible, but has taken student loans
- Students without federal aid

Summer 2021

- \$725 to Pell eligible students
- \$500 to students who were not Pell eligible, but took student loans
- \$200 to students without federal aid

Fall 2021

- \$625 to Pell eligible students
- \$400 to students who were not Pell eligible but took student loans
- \$200 to students without federal aid

Once these initial disbursements were made we had additional funds remaining. We communicated with students informing them of a secondary application where they could request additional funds if they felt we had misidentified their level of need. An additional \$300 was disbursed to students who applied.

7. Any instructions, directions, or guidance provided by the institution to students concerning the Emergency Financial Aid Grants.

Students were notified, via email and e-campus update, that funding was available, and an online application had to be submitted to verify eligibility and receive an award. Students that were not awarded received an email indicating why they weren't eligible for the funds.
